

This training uses the award-winning HBO documentary, 3 1/2 Minutes, 10 Bullets as a platform to examine the past, present, and future of police-community relations in America. It counters some of the false narratives surrounding law enforcement and community and provides police practitioners with the tools to address fear and bias (both explicit and implicit). Drawing on research from the fields of sociology, psychology, criminology, public health, and more, this training also examines the causes and consequences of crime and responses to crime and shares best practices in police officer safety and wellness. Be prepared for difficult, dynamic, discussions, facilitated by two award-winning college professors, and the development of a strategy for building community trust. In the end, participants will be empowered to make law enforcement more responsive to the concerns of communities of color and to bring about positive change for everyone.

**Dr. James Densley** is an Associate Professor of Criminal Justice at Metropolitan State University, part of the Minnesota State system. He has received local, national, and international media attention for his work on street gangs, criminal networks, violence, and policing. Densley is the author of *Minnesota's Criminal Justice System* (Carolina Academic Press, 2016), the award-winning *How Gangs Work* (Palgrave Macmillan, 2013), and over 20 refereed articles and book chapters in leading social science outlets.
